6. The continuation of provisional affiliation granted is subject to the condition that with regard to the admission of students, collection of fee, etc. the management should abide by the provisions of the Act, Statutes and Regulations of the University.

7. Selection and Admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.
8. In the light of the directions of the Hon'ble Supreme Court of India in WP (C) 656/1998 the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances, appropriate action, including withdrawal of affiliation of the college will be initiated.
9. A list of colleges, which have renewed their provisional affiliation or applied for Continuation of Provisional Affiliation will be forwarded to the office of the Controller of Examinations to see that examinations are not conducted in those colleges which have not applied for the Continuation of Provisional Affiliation.
10. Affiliation granted is strictly provisional and only for the academic year 2018-19. The college has to apply for the continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the University.
11. Admission to the next academic year shall be made only after obtaining prior permission from the University.
12. As per the UO No. 5869/2015/Admn dated 09.06.2015, the conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
13. The Principal should strictly follow the approved syllabus, which is available on the official website of the University (www.universityofcalicut.info) while selecting the Complementary courses.
