WHEREAS:

(A) First party is a IT company named as:

2. The MOU may be terminated by either party without assigning any reason by giving 15 days prior written notice to the other party

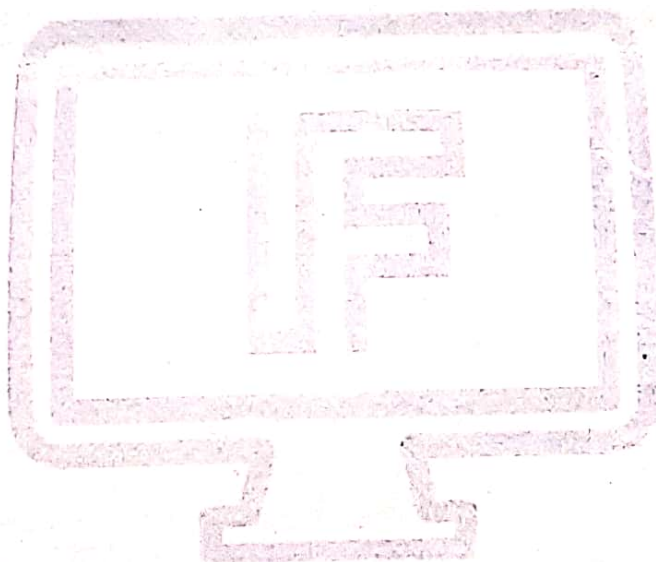
